The Antrobus family of Kent Green, Congleton, & Eaton, from c.1570

In spite of its exotic sound, the Antrobus family took their name from the village of Antrobus in NW Cheshire. The family tradition is that Henry Antrobus of Antrobus sold his estate there to the Venables family in 1460. The main concentration of the surname thereafter was in Over Peover. Edmund Antrobus came to Kent Green from Over Peover in or about 1600, on marrying Jane Cartwright, of either Kent Green or Bank. In fact since the subsequent Antrobus land holdings were mostly to the east of the road through Kent Green & stretched high up the hillside, the probability is that they lived on the lower hillside, not at modern-day Kent Green (the building of the canal in 1831 & railway in 1848 redefining what was called 'Kent Green'), possibly at the original Lower Bank Farm, off the lower leg of Spring Bank (abandoned & rebuilt on a new site further up in the 1840s). For four generations they were important local yeomen, owning (& buying & selling) land, in particular the Great Close on Mole, & involved as partners or financiers in the millstone quarries. The latter continued even after they moved to Congleton, both Philips being partners in the lease of quarrying rights from Sneyd (Tunstall manor) from 1731 to 1780. Philip jnr's son Edmund did very well from his inherited wealth & property, was made a baronet in 1815, & being unmarried divided it between his two nephews, whose parents had both died when they were babies, Eaton & the historic land holdings on the side of Mow Cop passing to Gibbs Crawfurd Antrobus. The baronetcy also came to the latter's descendants eventually, by a circuitous route. Note that G. C. Antrobus's mother & both his wives died in childbirth, painfully demonstrating that wealth for all its privileges didn't protect them from the most common cause of death in young women.
