The Battersby family of Biddulph Moor, from 1797

Thomas Battersby, a native of Leigh, Lancashire, married a member of one of Biddulph Moor's main families the Lancasters in 1827. To say he settled on the Moor is premature, because he & his adopted family were pot sellers. He is one of the few outsiders to join the notoriously insular community. Hannah's parents were pot seller Thomas Lancaster (1768-1830) & Hannah Shufflebotham (1766-1828), from another of the old pot selling dynasties, who married in 1793. Thomas Battersby can't be found in the 1841 or 1871 censuses (often the case with the semiitinerant pot sellers); in 1851 he's one of nine BM pot sellers staying in a doss-house in Preston, illustrating how they travelled around in such groups & lodged in the cheapest accommodation; in 1861 and 1881 (his age given as 82) he's at home at Wiltons, a smallholding near Ridgefield, BM. His age is given very consistently in censuses, implying a birth-date of 1798/9, but no baptism has been found to match this; however two TBs were baptised at Leigh in 1797, of whom the son of Robert & Peggy is unlikely in view of the Christian names but the illegitimate son of Sally (bap. June 4, 1797) seems a very likely candidate, both from the priority given to Sarah in the naming of his own children as well from as the lack of roots in his native Leigh that allowed him to join the 'Biddle Moor folk'. Three of their sons were also pot sellers, Thomas jnr intermittently working as a collier; while the youngest son James took up the other traditional BM occupation of stone mason. Their trading clearly focused on Warrington, which was an important pot selling centre.

Thomas (1834-1878) in 51 aged 16 he's one of a group of pot sellers led by Thomas Shufflebotham of BM, living or lodging at High Leigh, Cheshire (not the same Leigh where the Battersbys originated); coal miner (eg 1859), pot seller = 1855 at Horton, Sarah Bailey (1834/5-1917) dtr of Simeon & Jane, pot seller, sister of Mary (above) / Thomas d.at Warrington either visiting or pot selling, they weren't living there; Sarah (called 'Farmer's Wife') & the 2 boys are on BM in 1871 but Thomas absent, & she's a widow with lodgers in 1881, later that year marrying 2ndly Thomas Shufflebotham, widower b.c.1818 farmer

^{*} poor James, who died as a baby, is an interesting example of a common error; 1911 was the first census form people were expected to fill in themselves, but it was designed to be understood by bureaucrats not bricklayers; the enumerators were supposed to check & correct them, but one of the most frequent mistakes & one of the most frequent things the checkers missed was caused by the triple question how many children, how many still living,

how many dead, which confused many people into thinking they had to list all their children, living or dead (whereas only the names of people living in the same house were required); there are numerous examples both of dead children & of non-resident (eg grown-up) children listed, & not crossed out by the checkers; presumably the resulting 1911 population totals are greatly inflated as a result!
